



Benedetto Ermini

September 26, 1935 - March 3, 2026

After a long struggle with leukemia, Ben Ermini passed away at his home in Heritage Hunt.

He was born in 1935 in Yonkers, New York, was a graduate of Gorton High School, and attended Iona College. He was also a graduate of the FBI National Academy at Quantico, Virginia.

Ben retired from the Yonkers New York Police Department with the rank of Captain.

After retirement he became the Director for the National Center for Missing and Exploited Children (NCMEC). Using his Investigative knowledge and understanding of emerging technology, he designed processes that led to more successful outcomes for at risk children. This became his life's work and after First Lady Laura Bush toured NCMEC she became an avid supporter.

Ben is survived by his wife of 68 years, Kathleen Searles, his daughter, Lisa Ermini, his son, David, and three grandchildren. His son, Dr. Edward Ermini, predeceased him.

A Visitation will be held at Pierce Funeral Home in Manassas from 6-8 pm on March 10th. His funeral mass will follow at Holy Trinity Catholic Church on Wednesday, March 11th at 10:30 am.

He will be Interred at Stonewall Memory Gardens in Manassas, VA.
