



James C. Richards

May 4, 1953 - April 27, 2021

James Craig (“J.C.”) Richards died April 27, 2021, at his home in McLean, Virginia of pancreatic cancer. He was 67. J.C. was born May 4, 1953, in Bethesda, Maryland. He is survived by his wife, Monica, and their four children, David Richards (Courtney), Jessica Bennett (William), Katherine Revollo (Neil), and Stephen Richards (Andrea), as well as his three grandsons, Tanner, Matthew, and Theodore.

J.C. was raised in McLean and attended Langley High School. He graduated from the University of Pennsylvania Wharton School of Business. J.C. married the love of his life Monica Black in 1983. While raising their four children he worked as a real estate developer. He developed projects throughout Northern Virginia and Washington, DC, including acting as the owner’s representative for two award-winning projects, the Center for Strategic and International Studies Headquarters building and the Embassy of the United Arab Emirates Chancery Annex, both in Washington, DC. J.C. loved teaching and mentoring, including working as an adjunct professor and mentor to graduate students in the Georgetown University Master of Real Estate Program.

For decades—and long past his children’s involvement in the sport—J.C. spent many weekends every year on deck as a starter and referee for the Northern Virginia Swim League and USA Swimming. A member of The Church of Jesus Christ of Latter-day Saints, he was deeply involved in his faith community. He was a missionary in Puerto Rico, and served many years

as an ecclesiastical leader in English- and Spanish-speaking congregations and a teacher and mentor to young people. He will be remembered as a loving husband, devoted father and grandfather, and a generous teacher. A funeral service will be held on Wednesday, May 5, 2021 at 11:00 AM at The Church of Jesus Christ of Latter-day Saints, 1325 Scotts Run Road in McLean, Virginia and broadcast online (<https://zoom.us/j/92584449080>). The family will receive visitors beginning at 10:00 AM. COVID precautions will be observed.
